Vide reference 2nd cited, the Andhra Pradesh State Allied and Health Care Profession Council, Vijayawada (Established under National Commission for Allied and Healthcare Council Act, 2021) has granted temporary recognition under the provisions of the National Commission for Allied and Healthcare Council Act, 2021 to train the students in Bachelor of Physiotherapy course to Gayatri Vidya Parishad Institute of Healthcare and Medical Technology, Door No.6-25, Maridi Valley, Marikabvalasa, Madhurawada, Visakhapatnam – 530048.

In the reference 5th cited, the Principal Secretary to Government HM&FW (C2) Department, A.P., has informed that the State Allied Health Care Council is the Competent authority to accord Permission for establishment of New Allied and Health Care Institutions in the State of Andhra Pradesh.

In view of the above and subject to modification of the Statute concerned, the University has constituted inspection committee to inspect **Gayatri Vidya Parishad Institute of Healthcare and Medical Technology, Visakhapatnam** for physical verification of the facilities available for granting Certificate of Registration-cum-Provisional Affiliation for starting of **1st year B.Sc MLT Course and for admitting the students with an intake of 30 (Thirty) for the academic year for the Academic year 2023-24.**

As per the report of the inspection committee certificate of APSAHPC, Vijayawada as per the letter of the Government vide reference 7th cited, and as per the orders of the Vice-Chancellor in the reference 9th cited, it is to certify that the application of **Gayatri Vidya Parishad Institute of Healthcare and Medical Technology, Door No.6-25, Maridi Valley, Marikabvalasa, Madhurawada, Visakhapatnam – 530048** established by Gayatri Vidya Parishad, Visakhapatnam for granting of Provisional Affiliation for starting of 1st year B.Sc MLT Course has been registered with Dr.YSR University of Health Sciences, Vijayawada for admitting the students with an intake of **30 (Thirty)** for the academic year **2023-24** as given below by following the due procedure.


Any deviation in this regard shall lead to disaffiliation of the college without any notice.


