The number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management quota as specified by the Medical Council of India / Dr. NTR UHS.

The fee collected by what so ever name called either for University quota seats or for management seats should not exceed the limits specified by the State Government/ Dr. NTR UHS from time to time.

The Management of the college shall follow the regulations made by the University/State Government and also the **Graduate Medical Education Regulations 1997** of the Medical Council of India in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice.
